

2019 FAULKNER COUNTY FAIR YOUTH TALENT CONTEST
(A Preliminary to the Arkansas State Fair Youth Talent Contest)

QUALIFICATIONS & RULES

1. The purpose of the Faulkner County Fair Youth Talent Contest is to discover, develop, and encourage talent in the youth of Faulkner County. It is designed primarily for amateur talent, but any act which qualifies otherwise is eligible, even if the act received pay at some time, except where the person(s) are actually engaged in the entertainment business or paid instructors of the Arts.
2. **Pre-Teen Contestants 10-13 years of age are not eligible to advance to the Arkansas State Fair however, they will be eligible for the Over-All Winner Cash Prize at Faulkner County. Contestants must be 14-17 years of age for Junior Talent and 18-23 years of age for Senior Talent by the opening day of the Arkansas State Fair (October 11, 2018). The Winner in each Category may represent Faulkner County and advance to the Arkansas State Fair.**
3. **Contestants in the Junior & Senior categories must legally reside in Faulkner County for six months immediately preceding the county contest or must be a full-time student who has attended an academic school within the county for one full semester immediately preceding the county contest. The Pre-Teen category will be OPEN to anyone within the ages of 10-13.**

4. Entry forms must be filled out completely and signed by authorized parties. Acts with five (5) or more contestants can designate one responsible adult for the group to sign the entry form who must also furnish a copy of the contest rules to each contestant in the act.
5. No contestant may be allowed to compete in more than two categories.
6. **Check-in Time will be at 5:30.** The Talent Show will begin at 6:30.
7. The Dress Code is completely optional, but attire **MUST** be in good taste and suitable for performance.
8. Contestants will be judged on Entertainment Value and Talent.
9. No decorative or background props of any kind will be allowed. A prop **MUST** be used as a functional part of the contestant's act.
10. Time Limit for each act is 3 minutes (including recorded introduction). You will not receive deductions at the County level, however, music will be faded at 3 minutes and 15 seconds. **If you advance to the State level, there is a mandatory time limit of 3 minutes.**
11. Musical accompaniment for any act must be recorded. Contestants must furnish their own CD's that must contain **ONLY** the music needed for the performance. It is recommended that contestant's bring a second CD to have in case of an emergency.
12. ALL CD's should be clearly marked with contestant (s) name and music title.
13. All CD's must be claimed immediately following the contest. The Faulkner County Fair Youth Talent Contest assumes **NO** responsibility for CD's left unclaimed.
14. No Dressing Area will be provided, however, there are restrooms available if needed to change into a costume. Faulkner County Fair Association **WILL NOT** be responsible for any items left in the restrooms.

15. No visitors are permitted back stage including: make-up artists, talent coaches, family or friends.
16. Any display of bad sportsmanship and/or unbecoming conduct, any interference and/or disturbance, foul language, or any other behavioral problem created by a contestant, parent, relative or supporter of a contestant could result in disqualification of the contestant not only from this year's pageant but all future contests.
17. There will be no admission to the Talent Competition, however, standard parking fees will apply.
18. No formal rehearsal will be held.
19. The Faulkner County Fair Talent & Pageant Director and or Faulkner County Fair Board reserve the final and absolute right to interpret these rules and arbitrarily settle and determine all matters, questions and differences in regard thereto, or otherwise arising out of or connected with, or incident to the contest, and the right to amend or add to these rules as their judgement may determine. Any contestant who fails to abide by any of the above rules can be disqualified from the competition by the Faulkner County Fair Talent & Pageant Director or Faulkner County Fair Board.
20. The Faulkner County Fair Association is not responsible for any lost, stolen, or damaged property. Please treat the facility with the utmost respect and clean-up after yourself when the event is over.
21. Fair and impartial judges are chosen by the Faulkner County Talent and Pageant Director. Contestant and/or parents are not to approach the judges at any time. Their decision will be final. All contestants are judged on Entertainment Value and Talent. Score sheets WILL NOT be available at any time for viewing.

COMPETITION CATEGORIES

VOCAL SOLO

Shall consist only of a vocal performance by one vocalist. You may accompany yourself with a musical instrument such as guitar or piano. CD's used for accompaniment will be allowed to provide limited vocal background but is not suggested.

VOCAL GROUP

Shall consist of two or no more than fifteen vocalists. No other talent may be performed. CD's used for accompaniment will be allowed to provide limited vocal background.

INSTRUMENTAL SOLO

Shall consist of an instrumental performance without vocal utterance by one performer. Taped accompaniment may be used. Contestants are encouraged to memorize their piece rather than use sheet music on stage. No piano or keyboard is available. NO DRUMS.

DANCE SOLO

Shall consist of one dancer. No other talent may be displayed in conjunction with the dance performance. All types of dancing will be judged in this category – tap, jazz, ballet, folk, ethnic, fad, etc. Gymnastics, tumbling, acrobatics, or any other form of gymnastics is not included in this category. However, a dance routine can include a maximum of two gymnastic or acrobatic stunts.

DANCE GROUP

Shall consist of two or no more than fifteen dancers. No other talent may be displayed in conjunction with the dance performance. The same rules listed under Dance Solo apply.

VARIETY

Shall consist of a performance of one or no more than fifteen people. This category is intended to provide a proper showcase for those acts in which multiple talents are displayed. Acts that fit the description of any other category will not be allowed to compete in this category. The following acts qualify for this category: song and dance, lip sync, pantomimes, impersonations, skits, juggling, ventriloquism, magic, baton and any other talent not applicable to any of the other categories. ***No act may include a drum set(s), beat boxing, paint/watercolor, swords, any open flame or any form of liquid.***
